FROM THE CHAIR AND CEO

It is our great pleasure to present the year-end report for 2023/24.

As we look back on an exciting year in tennis, we are proud of the significant achievements, the challenges overcome and the progress made towards our strategic goals, all of which underscore our commitment to the growth and development of all levels of tennis in New Zealand.

Our purpose to build community through tennis is reflected in our refreshed strategic framework, launched in June 2023.

This report highlights our key initiatives and financial performance as we strive towards our strategic goals. We extend our gratitude to our members, volunteers and partners, whose unwavering support is vital to our success.

GROW

Our grassroots programmes are thriving, introducing tennis to new players and fostering a love for the game among people of all ages across the country.

National programmes saw a 6% increase by the June year-end, with Hot Shots participation in schools up by an impressive 15%. Engagement with our Youth Advisory Group has also been fruitful, providing valuable insights into reaching younger audiences.

We continue to enhance club support through our online toolkit, regular newsletters, and webinars. The Love Tennis campaign also successfully engaged 146 clubs in 2023, marking a lively start to the last summer season.

We're pleased to report ongoing growth in the tennis community, with club membership increasing by 4% compared to last year. Notably, we've seen a 6% rise in the U18 age group and a 5% increase in the challenging 19-34 demographic.

Clubs are offering more flexible programmes, successfully attracting both returning and new players. Casual

participation surged by 30%, largely driven by the continued digitisation of the sport and the accessibility provided by tools like Book a Court.

This year, 59 clubs (up from 45) used the booking system, generating approximately \$128,000 for the individual participating clubs.

CONNECT

Tennis NZ has developed a comprehensive digital strategy to drive future growth, focusing on providing a suite of digital products for our community.

These products include the national CRM database, an online court booking system (Book a Court), and a new league management system to replace Match Hub.

We have also adopted the ITF World Tennis Number (WTN), enabling every player in New Zealand to compare their rating with both domestic and international competitors. The WTN is now widely used by federations for tournament gradings and by the Intercollegiate Tennis Association in the U.S.

Our national database has surpassed 90,000 active contacts. For member management, the Clubspark digital platform provided by Tennis NZ is now used by 161 clubs, seamlessly integrating with the national database.

Since its launch in 2023, the automated system for police vetting has been adopted by 155 clubs. Coach registration has also been operational for over 12 months, with 172 ITF Level 1 qualified coaches now

registered across 142 clubs. These clubs benefit from registration, as members can easily see if their coach has been police vetted and what their level of qualification is.

Our bicultural journey continues. Since September 2023, we've been honoured to partner with local iwi to hold pōwhiri welcomes for three visiting Davis Cup teams: Thailand in Invercargill, Türkiye in Auckland, and most recently Luxembourg in Palmerston North.

Alongside the Aotearoa Māori Tennis Association (AMTA), we surveyed Māori tennis players to understand their needs. With nearly 300 respondents from across the motu, the insights gained will shape the direction of future wānanga.

The survey highlighted three key areas of focus: Access, Belonging, and Participation/Events. We will continue working with Aotearoa Māori Tennis to develop initiatives that support growth in these areas.

WIN

Throughout the year, our athletes delivered exceptional performances at the ASB Classic, tournaments in New Zealand, and on the international stage, showcasing their remarkable talent and dedication.

We're encouraged by the growth of junior athletes reaching international benchmarks, with more qualifying as Gold athletes in our Targeted Athlete Programme. The number of New Zealand professional players holding WTA/ATP rankings remains steady at 41.

The four World Tennis Tour entry-level pro events held



in Wellington and Pāpāmoa delivered high-quality competition for athletes and provided development opportunities for local officials. This aligns with the Tennis NZ-led officials development programme now in place.

This year, the NZ Wheelchair Tennis Championships were successfully hosted alongside the EVES Open in Pāpāmoa, boosting broader community engagement. Events like the EVES Open World Tennis Tour School Visits and Holiday Programme further contributed to the success in Pāpāmoa.

Our top international professional players achieved remarkable milestones. Building on her Grand Slam doubles win at the 2023 US Open, Erin Routliffe was crowned the WTA's No. 1 doubles player after Wimbledon, where she was runner-up with Gaby Dabrowski.

Lulu Sun began representing New Zealand at the Billie Jean King Cup tie in April, and we take immense pride in her reaching the Wimbledon quarterfinals as a qualifier. Wimbledon also saw Mike Venus reach the semifinals in both men's doubles and mixed doubles with Erin.

Their success significantly boosted our social media presence, increasing our content, reach, and engagement. Over 1.7 million accounts were reached through the year to June, and our Facebook and Instagram followers grew by 12%.

In July, we celebrated our first-ever women's doubles team competing at the Paris Olympics. It truly has been an exceptional year for our top New Zealand players.

We acknowledge the transition in leadership within the Davis Cup team and extend our gratitude to former Captain Kelly Evernden for his contributions over the past two years. We welcome Artem Sitak as the new Davis Cup Captain and Matt Hair as the Billie Jean King Cup Captain, following Marina Erakovic's retirement. We sincerely thank both Kiwi tennis greats for their time and energy leading our national teams.

At the most recent Davis Cup tie (September 2024), New Zealand's most capped player, Rubin Statham, announced his retirement from Davis Cup.

Marcus Daniell has also announced that the 2025 ASB Classic will be his final event as a pro player. At the Paris Olympics, Marcus was elected to the International Olympic Committee (IOC) Athlete Commission—an esteemed recognition of his contributions to the sport. Our thanks go to Rubin and Marcus for their tireless commitment to the game.

ASB CLASSIC

The 2024 ASB Classic exceeded all expectations - ticket sales and commercial partnerships surpassed all previous years. The playing field was again incredibly strong, a huge testament to the Tournament Director Nicolas Lamperin.



Thanks to all the staff and the massive volunteer crew who deliver this fantastic event. Thanks also to all commercial partners, especially ASB who have partnered with the tournament for over 25 years.

ENABLE: MODERNISING TENNIS

The Tennis NZ Board has adopted a strategic approach to implementing changes prompted by the revised Incorporated Societies Act, viewing it as an opportunity to modernise our Constitution and future-proof our sport.

Based on recommendations from a Working Group convened in 2023, this year we have engaged with the tennis community to consider:

- Resetting the roles and responsibilities of organisations delivering support to clubs.
- Introducing a system-wide membership framework to keep participants safe, engaged, and connected.
- Enhancing digital connectivity to provide clubs with insights into participation, assist with compliance, and streamline administration through automated annual returns. This digitisation will also facilitate effective national and local marketing campaigns.

Over the next financial year changes will be finalised and Tennis NZ will work to ensure a smooth transition for all organisations, including assisting clubs in reregistering their updated constitutions.

FINANCES

Tennis NZ continues to maintain a strong financial position, enabling us to invest in programmes and initiatives that promote tennis at all levels.

However, TAB monthly revenue has not yet returned to pre-COVID levels, and we experienced a significant drop in expected revenue during the final two months of the year.

We are closely monitoring our financial situation and may need to adjust budgets in the 2024/25 fiscal year if TAB revenue remains volatile.

ACKNOWLEDGEMENTS

We would like to express our gratitude to our volunteer Board members, including new members Lisa Whyte and Stephen Bradley.

Since last year, we have bid farewell to Peter Maciaszek and Robyn Kiddle, both of whom made valuable contributions. Peter resigned after six years of dedicated service to the Board and its working groups.

We also recognise Rewa Harriman for her service as a

co-opted Board member, stemming from our partnership with AMTA, and we welcome Dee Isaacs into this role.

We celebrated the achievements of former Tennis NZ Chair and President Celia Patrick (ONZM), who received the Tennis NZ Te Tohu Taumata Lifetime Achievement honour at the 2023 AGM.

Seven recipients were honoured with the Tennis NZ Te Tohu Taumata Life Membership, recognising their significant contributions to our sport.

Julie Paterson was acknowledged on the King's Honours List in 2024 with the MNZM award for her services to Women and Sport.

With Tennis NZ now overseeing administration of both wheelchair tennis, and officials development, we would like to thank the volunteers of NZ Wheelchair Tennis and The NZ Tennis Umpires Association for their service and dedication.

We also recognise the dedication of the staff at Tennis NZ, especially during the busy summer season. We bid farewell to Shannon Hewetson, Adam Roberts and Amy March, and wish them well in their future endeavours.

Lastly, and most importantly, our heartfelt thanks go to the volunteers, players, coaches, partners, and all stakeholders whose contributions have been invaluable to our success in promoting tennis in New Zealand.

Together, we strive to make tennis accessible to all, inspiring the next generation of tennis enthusiasts and champions.

INTRODUCTION

We are thrilled to see the incredible mahi that our Regions, Associations, Clubs, Coaches, and volunteers continue to contribute to growing tennis within their communities.

The team at Tennis NZ wants to thank you for your dedication to ensuring everyone has a welcoming, quality, and enjoyable tennis experience, regardless of how they participate.

This year, we've been reflecting on how to further support growth in our sport, and the recently amended Incorporated Societies Act presents an opportunity to advance the Modernising Tennis plan.

Regions and Associations are working alongside Tennis NZ to prepare the network of tennis organisations for the required re-registration process under the Act.

CLUB MEMBERSHIP

Club membership has rebounded with another year of positive growth, thanks to the local efforts of clubs supported by their Associations and Regions.

Our annual club membership numbers have risen by 4%, totalling 43,034 (+1703 from 2022/23). This growth reflects the tireless work of countless volunteers and club

Nationally, significant growth was observed in the U18 (+6%) and 19-34 (+5%) demographics, which are vital as we cater to our tamariki, rangatahi, and the challenging 19-34 age group.

Clubs are introducing new and flexible offerings that attract both lapsed and new players in this typically declining age group.




CASUAL PARTICIPATION

This year, we saw a dramatic 30% increase in casual players, it highlights the importance of clubs forging strong personal connections to those in the community who choose to play on a casual basis. Offerings that are flexible and meet the needs of casual participants continue to be important area of growth for clubs.


The increase of casual participants by 7,361 demonstrates the value of initiatives like Book a Court.

By digitising our sport, clubs can understand diverse participation methods and create stronger connections into their community. Across all venues turnover from Book A Court was over \$400k and creates greater investment in the tennis ecosystem.

NATIONAL PROGRAMMES

This year, in conjunction with Tennis Australia, we refreshed the branding and programmes for Tennis Hot Shots and Cardio Tennis. This refresh gave the brands a more modern and mature feel, appealing to a wider audience without losing their fundamental philosophies, resulting in a 6% increase in national programme participation this year.

Tennis NZ rolled out this rebranding throughout the year, working with coaches and deliverers to ensure they understood the changes and benefits of the new programmes and had the necessary resources and branding to promote their delivery to the community.

We saw a 15% increase in Tennis Hot Shots delivery into schools this year, which is pleasing as this is a key market for coaches and clubs to engage participants and build connections for lifelong engagement.

The revamped Cardio Tennis programme offered deliverers more flexibility and diversity, allowing for a broader, more tailored participant experience elements our deliverers had been requesting. This led to a 32% increase in the number of Cardio participants across the country this year, which is fantastic to see.

TENNIS NZ YOUTH ADVISORY GROUP

In its second year, the Youth Advisory Group (YAG) has continued to engage youth in shaping the future of our sport. The eight members of the group are passionate and experienced – a voice for their generation.

This year, they focused on building a formal Youth Strategy and how they can continue to influence the future of tennis in NZ.

Strategic aims include how tennis connects digitally to the younger generation, and the accessibility of tennis.

We want to thank the group for their commitment and enthusiasm this year.









MODERNISING TENNIS PLAN

With the changes to the new Incorporated Societies Act, Tennis NZ and the Regions have continued this year to plan for the re-registration of all tennis organisations in a way that enables the Modernising Tennis Plan.

Through a collaborative and consultative approach, we have developed four changes that will help modernise our sport and ensure all constitutions comply with the new Act, making it easier to administer and deliver services from the network of clubs.

Change 1 – Membership and Delivery Structure.

This is a reset of the current Region plus Association model where the voting members of Tennis NZ will be Regional Tennis Organisations (RTOs) who lead the delivery of services within their regions. They may have one or more Local Tennis Partners (LTPs) who they work with in delivering a subset of services to the clubs in their area.

Change 2 – Upgrading Digital Connectivity.

This change aims to connect all of our clubs digitally to a national database. Among other benefits, it will allow for automated annual returns, local-level data insights to support funding applications, compliance with member record-keeping requirements of the Incorporated Societies Act, and simpler national communications regarding events such as Love Tennis.

${\bf Change~3-Systemwide~Membership~Approach.}$

Building on Change 2, we aim to move to a system wide membership approach which will promote a fully connected system that fosters greater involvement, connection, and safety for all participants.

Leveraging the membership provisions of the new Act, this change extends the support of essential Tennis NZ national policies to more participants.

Change 4 – Constitutional Updates.

A suite of constitutional updates, amendments and changes that ensure all constitutions meet the requirements of the new Incorporated Societies Act. This ensures our whole system has best practice and future-proofed constitutions.

Tennis NZ belives these changes will continue to prepare the sport for the future.

MĀORI IN TENNIS SURVEY

As part of our ongoing rangapū with Aotearoa Māori Tennis (AMTA), we conducted a survey to better understand and increase Māori participation and engagement in tennis. The survey reached current, lapsed, and non-tennis participants.

The survey aimed to:


- Connect with the Māori community to gather insights on their tennis experiences.
- Engage other stakeholders so non-Māori who coach or support young Māori are better supported in their efforts.

As we work to develop Te Tiriti o Waitangi strategies in conjunction with AMTA, it is hoped that this survey will provide insight to things like:

- Bi-cultural practices at Region and Association
 level
- Understanding the Māori tennis community who are currently engaged in tennis.
- Learning from Māori who don't currently have a connection to tennis but have done in the past.

With nearly 300 respondents, the survey results are helping to shape future intiatives.

Three primary areas of focus emerged: Access, Belonging, and Participation/Events.

CLUB SUPPORT

Tennis NZ is dedicated to helping clubs provide quality, accessible experiences to their communities.

The 2023 Love Tennis campaign was a huge success, with 146 clubs participating in this September open day.

Significant effort was made by local clubs supported by their Regions and Associations in driving participation on the day.

Tennis NZ is committed to improving this campaign to foster community engagement and increase participant retention following Love Tennis.



CLUB SUPPORT HIGHLIGHTS

- Expanded the online Club Toolkit, providing resources for best practices in club operations.
- Grew the Club Matters Facebook group from 604 to 833 members.
- Wrote monthly newsletters sharing support opportunities and case studies.
- Collaborated with the National Youth Advisory Group to learn how clubs can engage more effectively with Gen Z and young people.
- Hosted nine webinars on topics like digital capability, member retention, player engagement, and effective club management.
- Initiated a club pilot programme called
 Open Court, to attract younger players and provide varied tennis experiences.
- Launched a second shared administration pilot with two Nelson clubs. The first was in the Tennis Northern Region last year.

COACH DEVELOPMENT

Coaches play a vital role in creating quality experiences and a lifelong love of tennis for participants.

We want to support and develop individuals who choose coaching as a part-time job or a full-time career, and we know that there is still a shortage of tennis coaches around the country.

We continue to work on ensuring there are numerous opportunities for current or aspiring coaches and this year we delivered a total of 75 coach education courses, webinars, forums, and other development opportunities.


We also supported coaches with 22 performancerelated development opportunities.

With the National Coach Register now fully in place, more coaches are working to gain qualifications and publicly demonstrate their commitment to best practice teaching, safeguarding, first aid and professional standards.

With over 400 coaches on the register, the tennis community can feel confident that those they are learning from are creating the best experiences in the safest way possible.

CLUBSPARK & BOOK A COURT

The use of Clubspark and Book a Court by clubs continues to grow, with over 160 clubs now utilising Clubspark for online membership management and member interaction.

Through the Book a Court systems and hardware, clubs and tennis centres have generated over \$400,000 in casual booking revenue.

The introduction of low-cost padlock hardware for casual bookings has made it easier and more affordable for clubs to increase court usage within their communities. This cost-effective solution not only opens courts to a wider audience but also provides clubs with a valuable new revenue stream.



2023/24 was a year of change and growth for the High Performance team. A newly constructed team, new programmes created and new player in Lulu Sun joining our NZ tennis whānau and we said goodbye to a Davis Cup legend, Artem Sitak officially retiring at the ASB Classic in January after a highly successful career.

On the staff front Tennis NZ welcomed Chris Bint as National Coach and Alex Yang as National Physical Performance Coach, with Emily Carter appointed as Head of High Performance. We are also pleased to have secured Artem Sitak and Matt Hair, as the new Davis Cup and Billie Jean King Cup Captains from September and November 2024.

In Juniors, we saw a significant rise in the number of players meeting Gold Criteria suggesting an increase in depth across the country with more players meeting international standards. This was reflected in our team performances, which saw improvements in nearly all age groups and included an Australian Team Event win, the first title won in a number of years across the ditch.

We sought to bring our best players together often, running ten residential camps across Martinborough and Auckland, and added a new event to the tournament calendar - the inaugural Kiwi Clay Championships. Held in February 2024 this was the first ever clay event in NZ.

Tennis NZ supported over 40 players on international tours, including nine gold-level athletes funded by Tennis NZ and 11 silver-level athletes who participated at their own expense.

Additionally, 18 promising juniors and wider Davis Cup/ Billie Jean King Cup squad members joined, making up a robust representation of emerging talent. Athletes meeting criteria also benefited from our new Wellbeing Programme, designed to provide high-performance

players with support in the areas of mental skills and overall wellbeing.

Looking to build for the future, more time was invested into building our pathways continuing the College Support Programme and creating the Pro Player Support Programme to be launched in 2024/25, the goal being to successfully support players through college and the professional tour, providing a complete pathway of peformance support from junior to pro level.

Professionally it was an incredible year for women's tennis. Erin Routliffe shone, winning a Grand Slam in 2023 and obtaining the prestigious World Number One ranking in July 2024.

Lulu Sun made a commitment to NZ in February 2024, rising rapidly in the singles rankings and wowing the nation with a breakthrough Wimbledon performance reaching a history-making quarter-final.

WORLD-CLASS HIGH PERFORMANCE SYSTEMS THAT AID ATHLETES, COACHES AND **SUPPORT STAFF**

Tennis NZ's high-performance systems are benchmarked against leading programmes worldwide, ensuring Kiwi players competing internationally receive top-tier support from our coaches, programmes, and staff.

A notable initiative this year was the introduction of training camps and competitions on high-quality clay courts at the new Red Clay Tennis facility in the Wairarapa. This has given promising young players the chance to sharpen their skills on clay without the high costs of overseas travel. Tennis NZ has officially taken over the administration and development of tennis officials, ensuring the long-term sustainability of officiating pathways.

We are delivering training courses, increasing the number of ITF-sanctioned events in New Zealand, and helping our top officials secure Prime Minister's Scholarships to gain experience at major international tournaments.

BILLIE JEAN KING CUP

This year, the New Zealand team competed in Group I in Changsha, China. The team included Erin Routliffe, Valentina Ivanov, Paige Hourigan, Monique Barry, and debutant Lulu Sun. Under the captaincy of Matt Hair, they faced five other nations, battling for promotion to the World Group playoffs.

After a slow start adjusting to the clay courts, the team lost on Day 1 to a determined Korea Republic team. However, New Zealand rallied, putting up a strong fight against the top-seeded hosts, China. They went on to secure solid wins against India, Pacific Oceania, and Chinese Taipei, ensuring their spot in the group.

DAVIS CUP

New Zealand hosted two ties this year, playing against Turkey and Thailand. In September 2023, the team comprising Ajeet Rai, Isaac Becroft, Artem Sitak, Finn Reynolds, and Rubin Statham—faced Thailand at the ILT Stadium in Invercargill. Captained by Kelly Evernden, the team delivered strong performances, winning the tie 3-1.

In February 2024, the tie moved to Auckland, where the team—led again by Kelly Evernden—competed against Turkey at the ASB Stadium. The squad featured KP Pannu, Ajeet Rai, Marcus Daniell, Finn Reynolds, and Rubin Statham.

KP gave the team a strong start with a 6-3, 6-2 win, but the rest of the tie saw New Zealand narrowly lose in competitive matches, two of which went to three sets.

JUNIOR PLAYERS

KAI MILBURN

Kai won three New Zealand ITF singles titles at the J60 Christchurch, J60 Wellington, and J100 Auckland tournaments. He also made the quarterfinals of the J300 in Nonthaburi, Thailand, reaching a career-high ITF juniors ranking of #145.

AISHI DAS

Aishi reached a career-high ITF juniors ranking of #191 in early 2024. Highlights of the year include a semifinal appearance at the J200 (closed) Sydney, a quarterfinal at the J200 Sydney the following week, and a Round of 16 finish at the J300 in Wanju, Korea.

CODY ATKINSON

Cody enjoyed a breakthrough year, reaching a careerhigh ranking of #321.

This achievement followed two ITF title wins in Fiji at the J30 and J60 levels, as well as reaching the finals in another J60.

HARRY PUGH

Harry achieved a career-high junior ranking of #142 in January 2024. He reached the singles final at J100 events in Mexico and Canberra.

In doubles, Harry won the J200 title in Sydney and made the finals of the J300 in Wanju, Korea, the J100 and J200 events in Veracruz, Mexico, and the J100's in Brisbane and Canberra.

EUROPEAN TOUR TENNIS EUROPE RESULTS

NOA MILBURN

Noa won the singles title in Amsterdam (Cat 3) and finished runner-up in Kufstein, Austria (Cat 2). He also made a singles quarterfinal at the Cat 2 event in Fürstenfeld, Austria.

In doubles, Noa teamed up with Alvin Na to win titles in Eindhoven (Cat 2), Amsterdam (Cat 3), Fürstenfeld (Cat 2), and Kufstein (Cat 2). The duo also finished as runners-up in Augsburg, Germany (Cat 2).

ALVIN NA

Alvin claimed the singles title in Eindhoven, Netherlands (Cat 2) and was the runner-up to Noa Milburn in Amsterdam (Cat 3). As a doubles team, Alvin and Noa secured four titles and narrowly missed a fifth, finishing as finalists in their last tournament.

YASHWITHA REDDY

Yashwitha was highly successful in Europe winning Amsterdam (Cat 3) and finishing runner up at Jurmala (Cat 2) and Furstenfeld, Austria (Cat 2) as well as making a semifinal and two quarterfinals in the other Category 2 events.

Partnering with Una Misic, the pair won Amsterdam (Cat 3), Furstenfeld (Cat 2) as well as Ulm and Augsburg Category 2 events in Germany. Yashwitha also made the final of Kufstein (Cat 2) with a different partner.

UNA MISIC

Una reached the singles semifinals in Amsterdam (Cat 3) and Brasov, Romania (Cat 2), along with quarterfinals in Kufstein (Cat 2) and Augsburg (Cat 2).

In doubles, she won four titles partnering with Yashwitha, and made the final in Mogyorod, Hungary (Cat 2) with a separate partner.

DOREA MORINA

Dorea gained valuable experience in Europe, with her highlight being a singles quarterfinal appearance in Augsburg, Germany (Cat 2).

ROSALIE POLLYN

Rosalie reached the singles semifinals in Amsterdam (Cat 3) before competing in Germany and Luxembourg.



Erin has had an extraordinary year, starting with her historic win at the 2023 US Open, becoming the first New Zealand female (singles and doubles) to win a Grand Slam in 44 years.

Erin continued her success with titles at the WTA 500 Zhengzhou Open and WTA 250 Rothesay Open.

She was a finalist at Wimbledon, two WTA 1000 events (Miami and Rome), and the WTA 250 in Eastbourne, alongside multiple semifinal finishes, including at the Australian Open.

Erin made history by reaching a career-high doubles ranking of World Number 1. She also became part of the first-ever female New Zealand doubles pair to compete in the Olympics, partnering with Lulu Sun in a challenging match against the eventual champions, Italy's Sara Errani and Jasmine Paolini.

LULU SUN

Lulu made the decision to represent New Zealand in 2024, becoming the country's highest-ranked singles player.

Ranked around 180 at the start of the year, Lulu's 2024 campaign kicked off with a round of 16 appearance at the ASB Classic after coming through qualifying.

She went on to win an ITF W50 event in Great Britain in February and a W100 event in Bonita Springs, Florida, in May.

Lulu then made history as the first Kiwi woman since
Dame Ruia Morrison to reach the fourth round of
Wimbledon, going one step further reaching the
quarterfinals. She came through three rounds of
qualifying, then defeating World #8 Qinwen Zheng
and British favourite Emma Raducanu on Centre Court.
Lulu's WTA ranking climbed to a career-high #39.

MONIQUE BARRY

Monique reached career highs in singles (#544) and doubles (#411). She started the 2023/24 season by winning two ITF W15 titles in Caloundra, Australia, and

She earned a wildcard into the ASB Classic, defeating Elyse Tse in the playoff and putting up a competitive performance against World #74 Elina Avanesyan in the main draw.

Monique made her Billie Jean King Cup debut in the July tie in Malaysia and was selected again for the 2024 Group I tie in China.



MICHAEL VENUS

2023/24 saw Mike solidify his position within the top 20 doubles players in the world.

His highlights include winning the ATP 250 Qatar Open with Jamie Murray and excelling during the grass court season alongside Neal Skupski, where they won the Eastbourne ATP 250 and Queen's ATP 500. They also made it to the semifinals of Wimbledon.

Mike reached several finals with Murray, including the ATP 500 in Tokyo, ATP Masters in Cincinnati, and the ATP 250 in Adelaide.



VALENTINA IVANOV

In her final year at UC Berkeley, Valentina achieved a singles ranking of #52, with her team reaching the NCAA Division I Championships, advancing to the final 16.

Valentina represented New Zealand in both Billie Jean King Cup ties in July 2023 and April 2024, and has now transitioned to full-time professional tennis.



KIRANPAL PANNU

KP has had a standout year, finishing 2023/24 at a career-high ranking of #444.

After returning from injury in late 2023, KP began 2024 by winning the Wildcard playoff for a spot in the ASB Classic main draw, where he faced world #45 Max Purcell, losing 4-6, 4-6. He delivered the sole win for New Zealand in the Davis Cup tie against Turkiye.

KP continued his strong form by winning two M15 ITF titles in Santo Domingo and Jamaica, and reaching the final of the M25 in Anapoima. Colombia.

VIVIAN YANG

Vivian completed her freshman year at Pepperdine University, where the team reached the NCAA quarterfinals. Vivian was also selected for a second Billie Jean King Cup tie in July 2023, held in Malaysia.

ELYSE TSE

Elys reached a career-high singles ranking of #1069 while competing during her college breaks and completed her fourth year at Washington State University.

JADE OTWAY


Jade finished her third year at Texas Christian University (TCU) and competed in professional events during her college breaks. Jade made an impressive debut for the Billie Jean King Cup team in July 2023 in Malaysia, delivering strong performances in both singles and doubles.

AJEET RAI

Ajeet had a phenomenal year in doubles, winning seven M25 ITF titles across Asia and Australia.

He also reached the finals of the M15 Hong Kong, M25 Traralgon, and narrowly missed the title at the Indian Wells (2) ATP Challenger 50 doubles. These results propelled him to a career-high doubles ranking of #222 in June 2024.

In singles, Ajeet maintained a solid ranking within the top 500, currently ranked #497, highlighted by his victory at the M25 Cairns singles event.



FINN REYNOLDS

Finn had a breakout year on the doubles tour, claiming an M25 title in Calabasas and four M15 ITF titles in Wellington, Pāpāmoa, Valencia, and Forbach, France.

He also reached three M25 finals in Sarajevo, Georgia, and Thailand, and two M15 finals in Madrid and Alcala de Henares.

Notably, Finn secured his first ATP Challenger title at the Challenger 50 in Ibagué, Colombia, and narrowly missed out on another Challenger 50 title in Bolivia, losing 7-10 in the third set.

In August 2024, Finn captured his second ATP Challenger title (75) in Bogotá, pushing his career-high doubles ranking to #183.



Marcus returned from injury by winning two NZ M15 titles in Wellington and Pāpāmoa with Finn Reynolds. He then resumed competing on the ATP Tour, entering his final official year before his planned retirement in 2025.

While Marcus and Mike just missed out on Olympic qualification, Marcus achieved the honour of being elected to the IOC Athlete's Commission, where he will serve an eight-year term, ensuring athletes' voices are heard in Olympic decisions.

RUBIN STATHAM

Rubin made history for New Zealand in 2023, setting the record for the most Davis Cup appearances by a Kiwi, with his landmark match taking place during the September Invercargill tie against Thailand

On the tour, Rubin continued to compete in both si and doubles, reaching a doubles ranking of #188 and a singles ranking of #718 as of July 1, 2024.

JAMES WATT

James completed his first full year on the professional tour, claiming the doubles titles at the M25 Traralgon and M15 Caloundra events, while also reaching the doubles final at the M25 in Mildura. These performances took his doubles ranking to a career-high of #601 and his singles ranking to #1388 as of July 1, 2024.

JACK LOUTIT

Jack completed a successful freshman year at the University of Kentucky, winning the SEC Championships and reaching the quarterfinals of the NCAA Championship.

He was runner-up in the wildcard playoff for the ASB Classic, earning a qualifying wildcard and advancing to the second round.

During his college break, he competed in professional events, making the final of the M15 in Monastir, achieving a career-high ranking of #781.

ALEX KLINTCHAROV

Alex returned to the full-time professional tour in 2023/24, steadily building his ranking and reaching career-highs of #901 in singles and #1037 in doubles as of July 1, 2024.

CORBAN CROWTHER

Corban made significant progress in 2024, breaking into the top 1000 rankings. His best result came at the M15 in Pāpāmoa, helping him reach career-high rankings of #909 in singles and #1309 in doubles as of July 1, 2024.

ISAAC BECROFT

Isaac completed his fourth year at Oklahoma State, finishing with an ITA ranking of #82. He was also part of the winning Davis Cup team in Invercargill. During his college break, Isaac competed on the professional tour, making the final of the M15 in Caloundra.

REECE FALCK


After graduating from the University of North Carolina Wilmington in May, Reece transitioned to the full-time tour. He made the doubles final of the M15 in Pāpāmoa during the college break and continues to build his ranking, currently at #1603 in singles and #1403 in doubles as of July 1, 2024.

GEORGE STOUPE

In his fourth year at Louisiana State University, George helped his team reach the NCAA Division 1 Championships. During the New Zealand summer, he made the doubles final of the M15 in Pāpāmoa. Unfortunately, a shoulder injury prevented him from competing during his college break in 2024.

ANTON SHEPP

Anton finished his fourth year at the University of Texas, Arlington, and gained his first professional ranking. Through strong performances during his college break, Anton progressed to rankings of #1357 in singles and #2352 in doubles.

RESOURCES, TOOLKITS AND EXPERTISE TO GROW CAPABILITY ACROSS THE TENNIS NETWORK

Our online club toolkit continues to grow, offering a wealth of valuable resources to tennis clubs across the motu. Topics covered include Communications & Marketing, Sponsorship & Funding, Governance, Facilities, IT, and Health & Safety.

In the last year, Tennis NZ staff provided support through webinars, forums, and one-on-one training, giving clubs the chance to access new initiatives like Open Court—casual, fun tennis sessions designed for players aged 16-24.

NATIONAL MARKETING STRATEGIES INCLUDING LOVE TENNIS

Tennis NZ continues to expand its reach, connecting with thousands of potential new players and fans. Our flagship Love Tennis campaign remains one of New Zealand's most successful mass participation sports events, attracting thousands of participants from 146 clubs in 2023.

Other key marketing initiatives included:

- Hot Shots Crew 12-year-old Taylor Orme and her mum won the trip of a lifetime to the Australian Open, where Taylor performed the coin toss at Rod Laver Arena before a Grand Slam match.
- Te Wiki O Te Reo Māori With the support of Aotearoa Māori Tennis, we introduced tennis kupu (words) in te reo Māori.

Top Spin 2K - We helped launch the new Top Spin tennis game in NZ, featuring NZ's own ASB Tennis Arena as a playable venue. This initiative is part of our work exploring new ways to engage and play tennis – including e-sports competitions being held in 2024.

Social media engagement saw significant growth this vear:

- Over 1.7 million accounts reached
- 12% increase in Facebook and Instagram followers
- Our audience was 54% female and 46% male, with the largest age group being 35-44, trending toward 25-34.
- Top-performing content included: Erin Routliffe and Gaby Dabrowski winning the 2023 US Open Women's Doubles, Lulu Sun qualifying for the Wimbledon Main Draw, Love Tennis 2023, the National Programmes Roadshow, and the Top Spin 2K25 game featuring the ASB Tennis Centre.

The delivery of international tennis in New Zealand continues to excel, with the ASB Classic setting several records this year, including:

The ASB Classic remains a staple of the Auckland summer events scene, and Tennis NZ, alongside Tennis Auckland, is working to engage more diverse communities through the event.

Entry-level professional tour events in Wellington and Tauranga offered fantastic opportunities for emerging Kiwi players and local fans, solidifying their place in the NZ tennis calendar.


These tournaments also delivered key community initiatives, allowing us to highlight tennis through top athletes and strong community programmes.

TE TOHU HĀPAI LIFETIME SERVICE HONOURS

Tennis New Zealand recognises that at the heart of the delivery of the sport of tennis in New Zealand is the large body of volunteers who either provide governance of the sport throughout the country or who deliver the sport in many ways including as administrators, coaches and officials.

Many provide such contributions over many years, often decades, and sometimes over a lifetime and so Tennis New Zealand has established Te Tohu Hāpai, an honour providing national recognition for long service to the sport within New Zealand across a wide spectrum of forms of contributions.

There has been in existence for some decades both the constitutional Life Membership award of Tennis New Zealand which recognizes largely international contribution to the sport and through the same period the honorary life membership awards conferred locally by Regions and Tennis Associations.

Te Tohu Hāpai, being the newly instituted award, now provides national recognition for lifetime service and therefore complements the Tennis New Zealand Life Membership award (Te Tohu Taumata). The three concepts for Te Tohu Hāpai, being national recognition of long service:

He Ngakaunui - dedication / commitment to tennis **He Manaakitanga nui** - care / impact on tennis **He Kaitiakitanga** – stewardship / guardianship of tennis

INTERNATIONAL LAWN TENNIS CLUB OF NEW ZEALAND

The past year has been quite eventful for the International Tennis Club of NZ, a club comprising both players who have been ranked in NZ open rankings, and supporters of international tennis, some 200 members in total. We are part of an international group of some 42 similar clubs around the world, who meet and compete in various events.

MEMBERSHIP

Greater emphasis has been made on the expansion of our membership, with emphasis on women, those outside of Auckland, those actively playing, and usually those players who are now in their 30s, and may have more awareness of the benefits and merits of the IC movement. More than 20 new members were added in the past year.

ASB CLASSIC & INTERNATIONAL TOURNAMENTS

An important part of our calendar is always the Monday morning teas at the two ASB Classic tournaments in January. In recent times we have had top ranking members Erin Routliffe and Cam Norrie attend. Our appreciation goes to Tennis Auckland for generously facilitating these morning teas.

The IC of Canada brought a Team to play us in February 2024, both at Ngatira Tennis Club in Auckland, and at Hagley Park Club in Christchurch. This was the first time ever, it seems, that a touring side had played at two different NZ venues. Our teams triumphed at both! We selected two Teams to play IC Trophy Events on the grass at Wimbledon (in August 2024) on the occasion of the ICGB 100th anniversary. In fields of 32, our women placed 5th and our men 9th, both losing to strong Australian sides.

We have been preparing to defend our title at the next biennial Sedgman Tills Trophy event against IC Australia, which they will host in Melbourne in the middle weekend of the 2025 Australian Open, and it promises to be an outstanding occasion.















IC PHILANTHROPY - ACE PROGRAMME

A strong emphasis is placed by ICs worldwide on Philanthropy. ICNZ has been at the forefront of the development of the Programme of teaching life skills through tennis to disadvantaged children of primary school age.

Our ACE programme delivers a series of 8 lessons per Term in school hours at various low decile schools, primarily at Bairds Mainfreight School in Otara, but now expanding to other south Auckland schools. Volunteers from our members, working with professional coaches trained in the Programmes, are a key part of the undoubted success we are seeing from these efforts.

The ICNZ AGM was held in May in Auckland, with an attendance of more than 90, followed by a complimentary dinner funded by life member Brian Woolf. Ex-President, (and author of our worldfamous Newsletters) Cec McIntyre was awarded Life Membership.

Our incoming Committee was elected and includes Vice President Russell Tills, Secretary Angela Hart, Treasurer Chris Ronayne, John Mills, Stephanie Fleming, Jules Stephan, Peter Stokes, Tony Woolf, and new members Angela Swinkels, David Frank, and Dr Lesley Ferkins.

Like many other New Zealanders, we were saddened at the death of Sir Colin Maiden, who was our Patron. A great servant of the game, Sir Colin was an enthusiastic and committed ICNZ member, who contributed deeply to the Club.

NZ TENNIS UMPIRES ASSOCIATION

The 2023-2024 year was a significant year for officiating in New Zealand.

On 29 October 2023, a Special Annual General Meeting was held to wind up New Zealand Tennis Umpires Association (NZTUA) and Tennis NZ to oversee the primary responsibility of officiating in New Zealand.

The transition was completed following the summer season. Bronwyn Northgrave was appointed in March 2024 as the Officials Coordinator. The new part-time role focuses on the development and retention of officials, evaluations, pathway and coordinating courses.

Tracy O'Connor (previous NZTUA Administrator) will continue to coordinate the tournament application and rosters in the interim. The vision is that the Officials Coordinator role will expand and possibly include the application process as well.

Tennis NZ hosted the World Tennis Tour events in December 2023 for the second year in a row. These events have been crucial for our officials gaining much needed international events in New Zealand.

The 2024 ASB Classic was the final year for Line Umpires with the ATP and WTA announcing from 2025 all ATP 250 and higher tournaments are to have Electronic Line Calling (ELC). This was bittersweet for

our officials as there are still opportunities to attend the classic with Umpire Assistants roles, however a change with no on-court officiating. Line Umpires are grateful to still have opportunities at World Tennis Tour, ITF and Davis Cup Ties to Line Umpire in NZ.

We have held less courses over the summer season with the merger, however Bronwyn quickly started setting up courses throughout the country from March.

At an international level, we would like to congratulate Melissa Rigby for passing her Level 3 Chair Umpire Course and gaining her ITF Bronze Badge in February 2024.

Sandie Newton and Luis Silva were selected to Court Supervise in American Samoa for the Pacific Cup. Melissa Rigby and Hamish Masters were selected to line umpire at the Paris Olympic and Paralympic respectively.

2024-2025 will be a busy year and we want to thank all our officials throughout the country for their time and effort which has been much appreciated.

This new constitution not only meets modern standards but also reflects our shared vision for the growth and improvement of tennis in New Zealand.

Due to the time demands of the constitutional changes, the Tennis NZ New to Governance Programme was paused in 2024, as were the Board intern recruitment and the Tikanga Rua committee, due to capacity constraints.

A casual vacancy arose when Deputy Chair Robyn Kiddle relocated to Australia in March 2024.

Despite these challenges Board remains committed to Tennis NZ's bicultural journey, Tikanga Rua, with educational sessions led by newly co-opted Board member Dee Isaacs as well as oversight of management initiatives partnering with Aotearoa Māori Tennis Association.

Thanks are due to Tennis NZ Board members for their work on important committees and advisory groups alongside the main board meetings.

STATEMENT OF ACCOUNTING POLICIES

Te Tauāki Puka Kaute

Tennis New Zealand Incorporated For the year ended 30 June 2024

1. Reporting Entity

The reporting entity is Tennis New Zealand Incorporated ("Tennis NZ"). Tennis New Zealand Incorporated is domiciled in New Zealand and is a charitable organisation registered under the Incorporated Societies Act 1908 and the Charities Act 2005.

The financial statements of Tennis NZ are presented for the year ended 30 June 2024. These financial statements and the accompanying notes summarise the financial results of activities carried out by Tennis NZ which provides tennis sporting services and facilities to people living in the wider New Zealand area.

These financial statements have been approved and were authorised for issue by the Board on the 2 October 2024.

2. Statement of Compliance

The financial statements have been prepared in accordance with Generally Accepted Accounting Practice in New Zealand ("NZ GAAP"). They comply with Public Benefit Entity International Public Sector Accounting Standards ("PBE IPSAS") and other applicable financial reporting standards as appropriate that have been authorised for use by the External Reporting Board for Not-For-Profit entities. For the purposes of complying with NZ GAAP, Tennis NZ is a public benefit not-for-profit entity and is eligible to apply PBE IPSAS RDR on the basis that it does not have public accountability and it is not defined as large. The Board has elected to report in accordance with PBE Accounting Standards RDR.

3. Significant Accounting Policies

The significant accounting policies used in the preparation of these financial statements as set out below have been applied consistently to both years presented in these financial statements.

3.1 Basis of Measurement

These financial statements have been prepared on the basis of historical cost, as modified by the fair value measurement of non-derivative financial instruments.

3.2 Functional and Presentational Currency

The financial statements are presented in New Zealand dollars (\$), which is Tennis NZ's functional currency. All financial information presented in New Zealand dollars has been rounded to the nearest dollar.

3.3 Revenue

Revenue is recognised to the extent that it is probable that the economic benefit will flow to Tennis NZ and revenue can be reliably measured. Revenue is measured at the fair value of the consideration received. The following specific recognition criteria must be met before revenue is recognised.

Revenue from non-exchange transactions

Donations

Donations are recognised as revenue upon receipt and include any donations from the general public, or donations received for specific programmes or services.

Grant Revenue

Grant revenue includes grants given by other charitable organisations, philanthropic organisations and businesses. Grant revenue is recognised when the conditions attached to the grant have been complied with. Where there are unfulfilled conditions attaching to the grant, the amount relating to the unfulfilled condition is recognised as a liability and released to revenue as the conditions are fulfilled.

TAB Revenue

The TAB revenue is from commission on tennis betting and is recognised as revenue when entitled to be received.

Revenue from Exchange Transactions

Affiliation Fees

Affiliation fees received are initially recorded as income in advance and recognised in revenue evenly over the membership period.

Where coaches purchase specific services (for example, attendance at coaching and development courses), revenue is initially recorded as income in advance, and then recognised proportionally on the basis of the value of each session relative to the total value of the purchased services.

Interest Revenue

Interest revenue is recognised as it accrues, using the effective interest method

3.4 Financial Instruments

Financial assets and financial liabilities are recognised when Tennis NZ becomes a party to the contractual provisions of the financial instrument.

Tennis NZ derecognises a financial asset or, where applicable, a part of a financial asset or part of a group of similar financial assets when the rights to receive cash flows from the asset have expired or are waived, or Tennis NZ has transferred its rights to receive cash flows from the asset or has assumed an obligation to pay the received cash flows in full without material delay to a third party; and either:

- Tennis NZ has transferred substantially all the risks and rewards of the asset; or
- Tennis NZ has neither transferred nor retained substantially all the risks and rewards of the asset, but has transferred control of the asset.

Financial Assets

Financial assets within the scope of PBE IPSAS 29 Financial Instruments: Recognition and Measurement are classified as financial assets at fair value through surplus or deficit, loans and receivables, held-to-maturity investments or available-for-sale financial assets. The classifications of the financial assets are determined at initial recognition.

Loans and Receivables

Loans and receivables are non-derivative financial assets with fixed or determinable payments that are not quoted in an active market. After initial recognition, these are measured at amortised cost using the effective interest method, less any allowance for impairment. Tennis NZ's cash and cash equivalents, short-term investments, receivables from non-exchange transactions, receivables from exchange transactions and non-equity investments fall into this category of financial instruments.

Impairment of Financial Assets

A financial asset or a group of financial assets is impaired and impairment losses are incurred if there is objective evidence of impairment as a result of one or more events that occurred after the initial recognition of the asset (a 'loss event') and that loss event has an impact on the estimated future cash flows of the financial asset or the group of financial assets that can be reliably estimated.

STATEMENT OF ACCOUNTING POLICIES CONT'D

Ngā Tauākī Mahi Kaute

For financial assets carried at amortised cost, if there is objective evidence that an impairment loss on loans and receivables carried at amortised cost has been incurred, the amount of the loss is measured as the difference between the asset's carrying amount and the present value of the estimated future cashflows discounted at the financial asset's original effective interest rate. The carrying amount of the asset is reduced through the use of an allowance account. The amount of the loss is recognised in the surplus or deficit for the reporting period.

If in a subsequent period, the amount of the impairment loss decreases and the decrease can be related objectively to an event occurring after the impairment was recognised, the previously recognised impairment loss is reversed by adjusting the allowance account. If the reversal results in the carrying amount exceeding its amortised cost, the amount of the reversal is recognised in surplus or deficit.

Financial Liabilities

Tennis NZ's financial liabilities include trade and other creditors (excluding GST and PAYE), employee entitlements and deferred income (in respect to grants whose conditions are yet to be complied with).

All financial liabilities are initially recognised at fair value (plus transaction cost for financial liabilities not at fair value through surplus or deficit) and are measured subsequently at amortised cost using the effective interest method.

3.5 Cash and Cash Equivalents

Cash and cash equivalents are short term, highly liquid investments that are readily convertible to known amounts of cash and which are subject to an insignificant risk of changes in value.

3.6 Property, Plant and Equipment

Items of property, plant and equipment are measured at cost less accumulated depreciation and impairment losses. Cost includes expenditure that is directly attributable to the acquisition of the asset.

Depreciation is charged on a straight-line basis over the useful life of the asset. Depreciation is charged at rates calculated to allocate the cost or valuation of the asset less any estimated residual value over its remaining useful life:

- Sporting equipment 3 years
- Office furniture / equipment 5 years
- Computer equipment / software 3 years

Depreciation methods, useful lives and residual values are reviewed at each reporting date and are adjusted if there is a change in the expected pattern of consumption of the future economic benefits or service potential embodied in the asset.

3.7 Intangible Assets

Intangible assets acquired separately are measured on initial recognition at cost. The cost of intangible assets acquired in a non-exchange transaction is their fair value at the date of the exchange.

Following initial recognition, intangible assets are carried at cost less any accumulated amortisation and accumulated impairment losses.

The useful lives of intangible assets are assessed as either finite or indefinite. Intangible assets with finite lives are amortised over the useful economic life and assessed for impairment whenever there is an indication that the intangible asset may be impaired. A review is made at least at the end of each financial period.

The amortisation expense on intangible assets with finite lives is recognised in surplus or deficit as the expense category that is consistent with the function of the intangible assets. Tennis NZ currently holds a Customer Relationship Management (CRM) System as an intangible asset, with an amortisation period of 6 years.

3.8 Employee Benefits

Wages, Salaries and Annual Leave

Liabilities for wages, salaries and annual leave are recognised in surplus or deficit during the period in which the employee provided the related services. Liabilities for the associated benefits are measured at the amounts expected to be paid when the liabilities are settled.

3.9 Income Tax

Due to its charitable status, Tennis NZ is exempt from income tax.

3.10 Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST except for receivables and payables, which are stated with the amount of GST included.

The net amount of GST recoverable from, or payable to, the Inland Revenue Department is included as part of receivables or payables in the statement of financial position.

Cash flows are included in the statement of cash flows on a gross basis and the GST component of cash flows arising from investing and financing activities, which is recoverable from, or payable to, the Inland Revenue Department is classified as part of operating cash flows.

3.11 Equity

Equity is the members interest in Tennis NZ, measured as the difference between total assets and total liabilities. Equity is made up of the following component:

Accumulated comprehensive income and expenses. This is Tennis NZ's accumulated surplus or deficit since its formation, adjusted for transfers to/from specific reserves.

3.12 Financial Accounting Standards

There were no new PBE IPSAS RDR standards that became effective in the current year that have an impact upon the Tennis NZ financial accounts.

4. Significant Accounting Judgements, Estimates and Assumptions

The preparation of Tennis NZ's financial statements requires management to make judgements, estimates and assumptions that affect the reported amounts of revenues, expenses, assets and liabilities, and the accompanying disclosures, including the disclosure of contingent liabilities. Uncertainty about these assumptions and estimates could result in outcomes that require a material adjustment to the carrying amount of assets or liabilities affected in future periods.

Judgements

In the process of applying Tennis NZ's accounting policies, management has made the following judgements, which have the most significant effect on the amounts recognised in the financial statements.

Use of Going Concern

The view of the Directors, is that Tennis NZ have sufficient resources to enable it to meet its obligations as and when they fall due and therefore continue to adopt the use of the going concern assumption in the preparation of the financial statements.

STATEMENT OF ACCOUNTING POLICIES CONT'D

Ngā Tauākī Mahi Kaute

Operating Lease Commitments

Leases in terms of which Tennis NZ does not retain all the significant risks and rewards of ownership, are accounted for as operating leases.

Operating lease rentals are recognised evenly over the expected period of the benefit to the organisation. In the event that lease incentives are received to enter into operating leases, such incentives are initially recorded as a liability and are recognised as a reduction of rental expense on a straight-line basis over the term of the lease.

Estimates and Assumptions

The key assumptions concerning the future and other key sources of estimation uncertainty at the reporting date, that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year, are described below. Tennis NZ based its assumptions and estimates on parameters available when the financial statements were prepared. Existing circumstances and assumptions about future developments, however, may change due to market changes or circumstances arising beyond the control of Tennis NZ. Such changes are reflected in the assumptions when they occur.

Useful Lives and Residual Values

The useful lives and residual values of assets are assessed using the following indicators to determine potential future use and value from disposal:

The condition of the asset

- The nature of the asset, its susceptibility and adaptability to changes in technology and processes
- The nature of the processes in which the asset is deployed
- Availability of funding to replace the asset
- Changes in the market in relation to the asset.

The estimated useful lives of the asset classes held by Tennis NZ are listed in Note 3.6.

5. Joint Ventures

Tennis New Zealand is a party to a joint arrangement when there is a contractual arrangement that confers joint control over the relevant activities of the arrangement to the entity and at least one other party.

Tennis New Zealand classifies its interests in joint arrangements as either:

- Joint ventures: where the entity has rights to only the net assets of the joint arrangement
- Joint operations: where the entity has both the rights to assets and obligations for the liabilities of the joint arrangement.

In assessing the classification of interests in joint arrangements, Tennis New Zealand considers:

- The structure of the joint arrangement
- The legal form of joint arrangements structured through a separate vehicle.
- The contractual terms of the joint arrangement agreement
- Any other facts and circumstances (including any other contractual arrangements).

Tennis New Zealand accounts for its interests in joint ventures using the equity method.

Any premium paid for an investment in a joint venture above the fair value of the entities share of the identifiable assets, liabilities and contingent liabilities acquired is capitalised and included in the carrying amount of the investment in joint venture. Where there is objective evidence that the investment in a joint venture has been impaired the carrying amount of the investment is tested for impairment in the same way as other non-financial assets.

Tennis New Zealand accounts for its interests joint operations by recognising its share of assets, liabilities, revenues and expenses in accordance with its contractually conferred rights and obligations. In accordance with PBE IPSAS 37 Joint Arrangements, the entity is required to apply all of the principles of PBE IFRS 3 Business Combinations when it acquires an interest in a joint operation that constitutes a business as defined by PBE IFRS 3.

Judgement

For all joint arrangements structured in separate vehicles Tennis New Zealand must assess the substance of the joint arrangement in determining whether it is classified as a joint venture or joint operation. This assessment requires Tennis New Zealand to consider whether it has rights to the joint arrangement's net assets (in which case it is classified as a joint venture), or rights to and obligations for specific assets, liabilities, expenses, and revenues (in which case it is classified as a joint operation). Factors the group must consider include:

- Structure
- Legal form
- Contractual agreement
- Other facts and circumstances.

Upon consideration of these factors, Tennis New Zealand has determined that all of its joint arrangements structured through separate vehicles give it rights to the net assets and are therefore classified as joint ventures.
